1 Name of Policy

This Policy is State Environmental Planning Policy Amendment (Land Use Zones) (No 4) 2022.

2 Commencement

This Policy commences on 26 April 2023 and is required to be published on the NSW legislation website.

3 Repeal of Policy

This Policy is repealed at the beginning of the day following the day on which this Policy commences.
