EXPLANATORY NOTE.

THE objects of this Bill are-

- (a) to repeal certain provisions of Part II of the Banks and Bank Holidays Act, 1912, including provisions relating to the submission by banks of quarterly returns to the Chief Secretary, and the registration of charters and names of proprietors of banks with the Registrar-General;
- (b) to repeal certain provisions of the said Act relating to bills of exchange, superseded by the Commonwealth Bills of Exchange Act, 1909;
- (c) to enable the holiday in respect of Australia Day (26th January) to be observed on the Monday following such date in those years in which such date does not fall on a Monday;
- (d) to enable the proclamation of a half-day as a public holiday.

A BILL

To make certain further provisions in relation to bank and public holidays; for these and other purposes to amend the Banks and Bank Holidays Act, 1912, as amended by subsequent Acts; and for purposes connected therewith.

B E it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of 5 the same, as follows :--
