A BILL

To make certain adjustments in the rates of pensions payable under the Coal and Oil Shale Mine Workers (Pensions) Act, 1941-1942; for this and other purposes to amend the said Act in certain respects; to validate certain matters; and for purposes connected therewith.

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. (1) This Act may be cited as the "Coal and Oil Short title Shale Mine Workers (Pensions) Further Amendment citation. Act, 1942."
