## A BILL

To vest certain lands in the Municipal Council of Sydney; to provide that certain roads be constructed, controlled, and maintained by the said council in consideration of such vesting; and for purposes consequent thereon or incidental thereto.

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South-Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Fish Markets Site short title. Vesting Act, 1915."

2. The lands described in the First Schedule hereto Vesting. are hereby vested in the Municipal Council of Sydney in

fee simple free from all trusts and dedications.

3. The Municipal Council of Sydney, in consideration Council to of the vesting mentioned in the preceding section, shall carry out and control certain undertake the construction, control, and maintenance works. of all roads and lanes within the area described in the Second Schedule hereto.

## SCHEDULES.

## FIRST SCHEDULE.

ALL that piece or parcel of land, containing by admeasurement 1 rood 32 perches, situate in the city of Sydney, parish of Alexandria, county of Cumberland, being allotment 1 of section 12 of a Government subdivision at Woolloomooloo Bay, commencing at the intersection of the southern side of Nicholson-street with the eastern side of Bourkestreet, and bounded thence on the west by the latter street southerly. 70 feet to Wilson-street; thence on the south by that street easterly 283 feet 9 inches to Forbes-street; thence on the east by that street northerly 70 feet to Nicholson-street before mentioned, and thence on the north by that street westerly 283 feet 9 inches to the point of commencement as indicated on plans catalogued S.299-858 and S.299A-858 in the Department of Lands.

All that piece or parcel of land, containing by admeasurement 1 rood 32 perches, situate in the city of Sydney, parish of Alexandria, county of Cumberland, being allotment 2 of section 12 of a Government subdivision at Woolloomooloo Bay, commencing at the intersection of the southern side of Wilson-street with the eastern side of Bourkestreet, and bounded thence on the west by the latter street southerly 70 feet to Plunkett-street; thence on the south by that street easterly 283 feet 9 inches to Forbes-street; thence on the east by that street northerly 70 feet to Wilson-street before mentioned; and thence on the north by that street westerly 283 feet 9 inches to the point of commencement, as shown on plans catalogued S.299-858 and S.299A-

858, in the Department of Lands.

## SECOND SCHEDULE.

All that piece or parcel of land, situated in the city of Sydney, county of Cumberland, parish of Alexandria, commencing at the intersection of the north-western side of Cook-road with the southern side of Parkroad, and bounded thence by the latter road westerly to its intersection with a north-eastern corner of an area of 23 acres 2 roods  $27\frac{1}{4}$  perches dedicated for military purposes, 18th October, 1899; thence by south-eastern and north-eastern boundaries of that area, and by the northeastern boundary of an area of 2 acres vested in the Royal Agricultural Society of New Sonth Wales, being lines south-westerly and southeasterly to the north-eastern corner of the last-mentioned area; thence by part of the south-eastern boundary of that land south-westerly to the north-western corner of an area of 3 acres 1 rood 1 perch vested in the Royal Agricultural Society of New South Wales; thence by the north-eastern boundary of the said land south-easterly to the northwestern side of Cook-road before mentioned; and thence by that road north-easterly to the point of commencement, as shown on Plan catalogued Ms. 4,339 Sy., in the Department of Lands.
