Preamble.

WHEREAS, in accordance with the provisions of the Public Works Act, 1912, the Legislative Assembly did, by resolution, declare that it was expedient to carry out a certain work, namely, the carrying out of a deviation of the Main Western Line 5 between Kelso and Raglan : And whereas, on the passing of the said resolution, a statutory duty was by the said Act imposed on the Minister to introduce a Bill into the said Assembly to sanction the carrying out of the said work : Be it therefore enacted by the King's Most 10 Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. This Act may be cited as the "Great Western 15 Railway Deviation (Kelso to Raglan) Act, 1916."

2. The carrying out the said work (more particularly described in the Schedule to this Act) is hereby sanctioned; and the Chief Commissioner for Railways aud Tramways is hereby authorised to undertake and 20 carry out the said work, subject to the provisions of this Act, and for that purpose shall be and shall have the powers of a Constructing Authority within the meaning of the Public Works Act, 1912.

3. The plan of the said work is the plan marked 25 "Great Western Railway Deviation, Kelso to Raglan," signed by the Chief Commissioner for Railways and Tramways and countersigned by the Engineer-in-Chief for Existing Lines, and deposited in the public office of the said Chief Commissioner. 30

4. The cost of carrying out the said work, estimated at one hundred and fifteen thousand pounds, may be defrayed from such loan votes as are now or may hereafter be applicable to that purpose, or from appropriations of the Public Works Fund, or partly from such votes 35 and partly from such appropriations.

5. The said line of railway may be constructed on or along or by the side of any public road or highway.

6. Notwithstanding the provisions of section ninetyone of the Public Works Act, 1912, the Constructing 40 Authority shall not be compelled, nor shall it be the duty

duty of the said authority to make or maintain any fence along the said line of railway for the accommodation of any person or for any purpose whatsoever; but the said authority may, in his discretion, make and 5 maintain such fences in connection with the said line of railway as he may think fit.
