EXPLANATORY NOTE.

THE main object of this bill is to take away from the Newcastle District Abattoir Board the power to purchase cattle and meat and the power to sell on its own behalf cattle and meat, including bacon, ham, sausages, saveloys and other smallgoods manufactured or prepared from a carcase or any portion thereof, leaving it with the power to sell such cattle and meat on behalf of other persons, and with the power to sell merchantable articles manufactured by the Board from offal in the abattoir.

The opportunity is also taken to bring the section relating to by-laws in line with the more modern form usually adopted.

A BILL

To limit the powers of the Newcastle District Abattoir Board in certain respects; to amend the Newcastle District Abattoir and Sale-yards Act, 1912, as amended by subsequent Acts; and for purposes connected therewith.

B^E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. (1) This Act may be cited as the "Newcastle Short title. District Abattoir and Sale-yards (Amendment) Act, 1935."

(2) The Newcastle District Abattoir and Sale-yards Act, 1912, as amended by subsequent Acts and by this Act, may be cited as the Newcastle District Abattoir and Sale-yards Act, 1912-1935.

2. (1) The Newcastle District Abattoir and Sale-yards Amendment of Act, 1912, as amended by subsequent Acts, is amended—^{Act No. 49},

- (a) (i) by omitting paragraph (b) of subsection Sec. 9 (4). four of section nine;
 - (ii) by omitting from paragraph (c) of the same ^{powers and} authorities.) subsection the words "either on its own behalf or ":
- (b) (i) by inserting in subsection one of section Sec. 26. twenty-six after the word "by-laws" where (By-laws.) firstly occurring the words "not inconsistent with this Act ";
 - (ii) by omitting from subsection two of the same section the words "and thereupon, but not sooner or otherwise, shall, subject to this Act, have the force of law" and by inserting in lieu thereof the words "Bylaws shall take effect from the date of their publication or from a later date specified in the by-laws ";
 - (iii) by omitting from the same subsection the words "days after the next meeting of Parliament", and by inserting in lieu thereof the words "sitting days after publication if Parliament is in session, and if not, then within fourteen sitting days after the commencement of the next session ";
 - (iv) by inserting in the same subsection after the words "disallowing any by-laws" the words " or part thereof ";
 - (v) by inserting in the same section after the words "such by-laws "where lastly occurring the words " or part."

(2) Any by-law made under the Newcastle District Abattoir and Sale-yards Act, 1912, as amended by subsequent Acts, in force at the commencement of this Act shall continue in force until repealed by a by-law made after such commencement.
