BILL A

To amend the Opticians Act, 1930-1931, and certain other Acts in certain respects; and for purposes connected therewith.

DE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :----

1. (1) This Act may be cited as the "Opticians short title (Amendment) Act, 1937."

(2) The Opticians Act, 1930-1931, as amended by this Act, may be cited as the Opticians Act, 1930-1937.

(3) Every registered optometrist shall, in or before the month of October in each year, pay to the Registrar a roll fee of such amount as may be prescribed for the following year.

The fee so prescribed shall not be less than ten shillings nor more than two pounds.

(4) If any registered optometrist does not pay the prescribed roll fee before the thirtyfirst day of October in any year the board shall notify him by registered letter addressed to him at the address appearing in the register. that if the fee be not paid within one month after the posting of the letter, his name will be removed from the register.

If any registered optometrist who has been so notified fails to pay such fee within the time specified in the letter, the board shall remove his name from the register.

(5) If the name of any registered optometrist is removed from the register under this section, the board, upon application in the prescribed form, shall, where such application is made within a period of two years after the name was so removed and may, where such application is made after the expiration of such period, restore his name to the register upon payment of such fees as are prescribed by the regulations made under this Act.

The regulations may provide for the waiver of such part of the fees as the board may, in a particular case, deem proper.

(6) Together with the roll fee the registered optometrist shall furnish particulars of his address for entry in the register.

(7) Where the name of any person has been removed from the register, and until the name has been restored thereto, such person shall be deemed

deemed to be a person who does not hold a certificate issued under this Act entitling him to practise optometry.
