**B**<sup>E</sup> it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :---

<sup>1. (1)</sup> This Act may be cited as the "Pawnbrokers Short title and Second-hand Dealers and Collectors (Amendment) and com-mencement. Act, 1933."

<sup>(2)</sup> The Pawnbrokers Act, 1902, as amended by this Act, may be cited as the "Pawnbrokers Act, 1902-1933."

(3) The Second-hand dealers and Collectors Act, 1906, as amended by subsequent Acts and this Act, may be cited as the "Second-hand Dealers and Collectors Act, 1906-1933."

(4) This Act shall commence upon a date to be appointed by the Governor and notified by proclamation published in the Gazette.

2. The Pawnbrokers Act, 1902, is amended by insert- Amendment of ing next after section thirteen the following new 1902. New sec. 13A section :---

13A. Every licensed pawnbroker shall upon the Returns to Monday in each week report to the Commissioner Commissioner of of Police in a form furnished by him, every article Police. received by the pawnbroker in pledge during the previous week.

3. The Second-hand Dealers and Collectors Act, 1906, Amendment of as amended by subsequent Acts, is amended—

- (a) (i) by inserting in the definition of "Old wares" Sec. 2. in section two, after the words "second-hand (Definijewellery" the words "second-hand bicycles, second-hand machinery of all descriptions'':
  - (ii) by omitting from the definition of the expression "Second-hand dealer" in the same section the words "whether such person" deals in any other goods or not" and by inserting in lieu thereof the words "or who buys old wares for use in the manufacture for sale or trade of goods of any description, whether such person deals in, buys, sells, or manufactures any other goods or not."
- (b) by inserting next after paragraph seven of Sec. 8. section eight the following words:-

(8) Make to the Commissioner of Police any Returns. return of all old wares purchased, received or sold in the course of business of the second-hand dealer required by the regulations made under this Act, at the time and in the form prescribed by such regulations.

(c) by omitting from subsection two of section ten sec. 10. the word "court" and by inserting in lieu thereof (Collectors licenses.) the word "clerk."
