A BILL

To remove the administration of Part VI of the Police Offences (Amendment) Act, 1908, from the Pharmacy Board of New South Wales; to amend in certain respects the Police Offences (Amendment) Act, 1908, and certain other Acts; and for purposes connected therewith.

B^E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :---

^{1. (1)} This Act may be cited as the "Police Offences short title. Amendment (Drugs) Act, 1932." ---(3) 78225

(2) This Act shall commence on a day to be appointed by the Governor and notified by proclamation published in the Gazette.

2. (1) From the commencement of this Act Part Removal of VI of the Police Offences (Amendment) Act, 1908 administra-(inserted by the Police Offences Amendment (Drugs) Part VI of Act, 1927), shall cease to be administered by the Act No. 12, 1908 (as Pharmacy Board of New South Wales, and shall be inserted by Act No. 7, administered by the Minister. 1927), from

All books, papers, and documents relating to such Pharmacy Board of administration shall on request be delivered by the said New South board to the Minister or to such officer as he may Wales. authorise to receive the same.

(2) The said Part is amended as follows:----

(b) be laid before both Houses of Parliament within fourteen sitting days after the publication thereof if Parliament is then in session, and if not, then within fourteen sitting days after the commencement of the next session.

If either House of Parliament passes a resolution of which notice has been given at any time within fifteen sitting days after such proclamation has been laid before such House disallowing any proclamation or part thereof, such proclamation or part shall thereupon cease to have effect.

(3) Any regulation made before the commence-saving. ment of the Police Offences Amendment (Drugs) Act, 1932, and in force at such commencement, shall continue in force until repealed by regulation made after such commencement.

(4) In the application of any regulation so continued and in the construction of any term or condition set out in any license any reference to the board shall be construed as a reference to the Minister, and a reference to an officer of the board shall be construed as a reference to an officer of the police force or of the Public Service authorised generally or specially by the Minister to perform any duty in respect of which the reference is made, and any matter or thing prescribed to be done upon the recommendation of the board may be done without any reference to the Pharmacy Board of New South Wales.

(1) Any person who forges or fraudu-Forging, &c., lently alters or utters, knowing it to be forged prescriptions. or fraudulently altered, any prescription of a 3^{r48, 1929} medical practitioner or registered veterinary (Vict.), s. 45; surgeon, including any drug to which this 1930 (Vict.), Part of this Act applies, shall be guilty of s. 6. an offence against this Part of this Act.

(2) Any person who knowingly by Obtaining, any false representation (whether verbal, or in &c., pre-scription by writing, or by conduct) obtains from any false repremedical practitioner or registered veterinary sentation. surgeon any prescription including any drug to which this Part of this Act applies, or induces any registered pharmacist to dispense any forged or fraudulently altered prescription, or any prescription obtained in contravention of this subsection, or is in actual possession of any forged or fraudulently altered prescription or any prescription obtained in contravention of this subsection, knowing the same
