A BILL

To amend the Entertainments Tax (Management) Act, 1929-1937, and the Totalizator Act, 1916-1937, in certain respects; and for purposes connected therewith.

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :--

1. This Act may be cited as the "Racing (Amend-^{Short title,} ment) Act, 1938."

Racing (Amendment).

2. (1) The Entertainments Tax (Management) Act, Amendment 1929-1937, is amended by omitting from section twenty- of Act No. five the word "upon" and by inserting in lieu thereof $\frac{56}{s.25}$. the words "or under the Racing Taxation Act, 1938, upon such".

(2) The Entertainments Tax (Management) Act, 1929-1937, as amended by this Act may be cited as the Entertainments Tax (Management) Act, 1929-1938.

(3) This section shall commence upon the date of commencement of the Racing Taxation Act, 1938.

3. (1) The Totalizator Act, 1916-1937, is amended by Amendment omitting subsection two of section eight, and by inserting in lieu thereof the following subsection:-

(2) (a) Every club using the totalizator under the provisions of this Act, and which conducts any meeting for horse-racing, pony-racing or greyhoundracing on any racecourse situated within forty miles of the General Post Office, Sydney (other than the Hawkesbury racecourse and the racecourse of the Menangle Park Racing Company Limited), shall pay five per centum of the amount so paid into the totalizator to the Colonial Treasurer or some person appointed by him, to be paid by him into the Treasury and carried to the Consolidated Revenue Fund.

(b) Every club using the totalizator under the provisions of this Act, and which-

(i) conducts race-meetings on any of the follow. ing racecourses, that is to say—

- The racecourse of the Menangle Park Racing Company Limited;
- The racecourse of the Kembla Grange Race Club Proprietary Limited;
- The racecourse of the Gosford Racing Club Limited;

- The racecourse of the Newcastle Jockey Club Limited;
- The racecourse of the Richmond Jockey Club Limited;
- The racecourse of the Wyong Park Racing Company, Proprietary, Limited;
- (ii) conducts meetings for trotting contests on a racecourse situated within forty miles of the General Post Office, Sydney; or
- (iii) conducts meetings for greyhound-racing on a racecourse situated beyond forty miles of the General Post Office, Sydney,

shall pay two per centum of the amount so paid into the totalizator to the Colonial Treasurer or some person appointed by him, to be paid by him into the Treasury and carried to the Consolidated Revenue Fund.

(2) The Totalizator Act, 1916-1937, as amended by this Act may be cited as the Totalizator Act, 1916-1938.

(3) The Racing (Amendment) Act, 1937, is Amendment amended by omitting subparagraph (ii) of paragraph (a) of section ten.

(4) This section shall commence upon the first day of March, one thousand nine hundred and thirty-eight.
