To authorise the establishment and carrying on of State industrial enterprises, and for the regulation of the same; and for purposes consequent thereon or incidental thereto.

E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "State Enterprises Short title. Act, 1920."

(2) This Act shall not apply to—

(2) The provisions set forth in the Schedule to 30 this Act shall be applicable to the business of the Schedule.

35 7. (1) The Governor may from time to time appoint Appointment a Commissioner for State Trade for a term not exceeding of Commissioner. five years.

(2) Upon the appointment of the Commissioner all the functions, duties, rights, liabilities, privileges, and 40 powers imposed and conferred upon the Commissioner under this Act or any other Act shall be vested in and be performed and exercised by such Commissioner.

8. (1) The Minister may appoint a secretary to the Commissioner, who shall, subject to the direction of the Commissioner, have power to execute documents on his behalf and affix the seal of the Commissioner thereto. He shall also have such other powers and perform such other duties as are from time to time determined by the Commissioner.

(2) In case of the illness, suspension, or absence of the Commissioner, the secretary, under the direction of the Minister, shall, during such illness, suspension, or 10 absence, have and exercise all the powers and perform all the duties of the Commissioner.

Salary of Commissioner. cf. Ibid: s. 8.

9. (1) The Commissioner shall, during his continuance in office, receive an annual salary, to be fixed by the Governor.

(2) Such salary shall be a charge upon and be paid out of the Consolidated Revenue Fund, which is hereby permanently appropriated for that purpose.

Commissioner to be a corporation sole-powers and liabilities. cf. Ibid. s. 9.

10. (1) The Commissioner, as representing the Crown, shall be a corporation sole by the name of "The 20 Commissioner for State Trade," and by that name shall have perpetual succession and an official seal which shall be judicially noticed, and shall be capable in law of suing and being sued, and shall have power to take, purchase, sell, exchange, lease, and hold land, goods, chattels, and 25 other property.

The Commissioner, as such corporation, for all the purposes of this Act, shall have and may exercise all the powers, privileges, rights, and remedies of the Crown.

(2) But, save as by this Act is expressly provided, 30 no exchange, sale, or lease of any land vested in the Commissioner shall have any effect unless and until the same has been approved by the Governor.

Disabilities.

11. The Commissioner shall not act as a director, cf. Ibid. s. 10. or auditor, or in any other capacity take part in the 35 management of any bank, joint-stock company, or other financial institution, or of any trade or business, or acquire or hold any interest in any land which may be required to be acquired, taken, or occupied for the purposes of this Act; and in any such case shall be 40 disqualified from holding the office of Commissioner.

12. The Commissioner may be suspended from his Suspension office by the Governor.

13. The Commissioner shall be deemed to have otherwise vacated his office—

vacated.

(1) if he is or becomes disqualified under this Act cf. Ibid. s. 12. from holding the office of Commissioner;

(2) if he engages, during his term of office, in any employment outside the duties of his office;

(3) if he is convicted of any felony;

10 (4) if he becomes insolvent, or institutes proceedings for liquidation of his affairs by arrangement or composition with, or assigns his salary for the benefit of, his creditors;

(5) if he absents himself from duty for a period of 15 fourteen consecutive days except on leave granted by the Minister (which leave is hereby authorised to be granted), or becomes incapable of performing his duties;

(6) if he becomes in any way concerned or interested 20 in any contract or agreement made by or on behalf of the Commissioner or in anywise participates or claims to be entitled to participate in the profit thereof or in any benefit or emolument arising therefrom.

14. On the occurrence of any vacancy in the office of Governor may fill vacancy. Commissioner, whether by effluxion of time or otherwise, ef. Ibid. s. 13. the Governor may appoint a person to fill the vacancy.

15. (1) The Commissioner may appoint and employ Managers such managers and such officers, clerks, and other and other employees.

30 employees to assist in the execution of this Act as he of the cf. Ibid. s. 16 thinks necessary.

(2) The Commissioner shall pay such salaries, wages, and allowances to the employees respectively as he may deem fit.

35 (3) No manager, officer, or other employee of any State enterprise shall have a pecuniary interest in any private business similar to that of the State enterprise in which he is employed.

(4) The Acts relating to the Public Service and 40 to Superannuation shall not apply to persons appointed under this section: Provided that any person so appointed

appointed who, prior to such appointment, was a contributor to the superannuation fund, shall be entitled to continue to contribute thereto.

- **16.** (1) Notwithstanding anything in the Audit Act, 1902, to the contrary there shall be created under this 5 Act, in respect of each State enterprise, a separate and distinct banking account to be called the "State [naming enterprise Account."
- (2) All moneys received by the Minister or Commissioner under this Act shall be paid into the proper 10 banking account.
- (3) All payments in respect of each State enterprise, together with such contributions to reserve fund or sinking fund, if any, as the Commissioner from time to time directs, shall be payable out of the proper banking 15 account.
- (4) All payments in respect of the administration of the State Trade Office and of this Act shall be apportioned between and payable out of the divers banking accounts created pursuant to this Act in such proportions 20 as the Commissioner from time to time directs.
- (5) The salaries, wages, and allowances of any officers or employees of the Public Service who are employed for any purposes under this Act shall be paid out of the account of the State enterprise in which they 25 are employed.

17. The Governor may from time to time, upon obtaining from the Commissioner such security as in the opinion of the Governor is necessary or desirable by warrant under the hand of the Colonial Treasurer, direct 30 and authorise loans to be made to the Commissioner out of the Loan Fund or by the issue of debentures, which debentures the Governor is hereby authorised to issue, for the purposes of the business of the Commissioner. Such loans shall bear such interest and shall be repayable 35 upon such terms as the Governor may determine.

Power to vest lands in the Commissioner.

18. (1) The Governor may at any time, by proclamation in the Gazette, vest in fee-simple in the Commissioner any Crown land to be used for the cf. Ibid. s. 19. purposes of the business of the Commissioner. 40

The

The value of any land vested in the Commissioner under this section shall be fixed by the Governor, and the amount thereof shall be debited against the proper fund.

(2) The Secretary for Lands may from time to setting time, by notification in the Gazette, set apart for the apart Crown U purposes of this Act any unalienated Crown lands, as defined in the Crown Lands Acts, which in his opinion may be required for the purposes of this Act, and may

10 from time to time, by like notification, exempt any of the said lands so set apart from the operation of this Act, and thereupon the lands so exempted shall cease to be subject thereto.

19. (1) The Governor may from time to time make Regulations. 15 all such regulations as he thinks fit for giving full effect to this Act.

(2) All regulations purporting to be made by the Governor shall be published in the Gazette, and upon such publication shall have the force of law.

1. For all the purposes of this Act—

General (i) The Commissioner shall have and may exercise all the commissioner. powers, privileges, rights, and remedies of the Crown;

(ii) All legal proceedings may be brought by or against the Commissioner in his official name.

The foregoing powers shall be in addition to any other powers conferred upon the Commissioner by this Act.

2. (1) On the passing of this Act—

(1) On the passing of this Act—

(a) All property, whether real or personal, corporeal or in Commissioner.

Vesting of assets and liabilities in Commissioner. corporeal, and all moneys and securities for money, and all interest thereon, and all books, documents, and other property held by or on behalf of any Minister of the Crown or State department or State officer in relation to or in connection with any State enterprise existing at the passing of this Act; and

(b) All the assets and liabilities of or in connection with any such enterprise;

and all powers, authorities, rights, title, interest, and obligation in or with respect to them or any of them, shall by virtue of this Act

pass to and become vested in and imposed upon the Commissioner, and shall forthwith be divested and discharged from the person or persons in or upon whom the same were formerly vested, conferred, or imposed.

Capital cost.

(2) For all purposes of this Act, the capital cost of each such 5 enterprise shall be deemed to be the amount appearing at the passing of this Act in the respective books of account as capital cost of each such enterprise.

Adjustment of

(3) The Colonial Treasurer shall cause to be made in the books of the Treasury such adjustment of accounts as will give due effect to the 10 foregoing provisions of this section.

Rights of action and under contracts.

(4) From and after the passing of this Act any right of action accrued to or against, and any agreement, mortgage, bond, lease, deed, guarantee, covenant, or obligation made or entered into by or with, the Crown or any Minister of the Crown or the Commissioner or State 15 department or State officer, in relation to or in connection with any enterprise aforesaid, may be prosecuted and enforced, by or against the Commissioner, as if the right of action had originally accrued to or against, or the agreement, mortgage, bond, lease, deed, guarantee, covenant, or obligation had been made or entered into by or with the 20 Commissioner.

Agents.

- 3. (1) The Commissioner may appoint any person to act as his agent. At the request of the Commissioner, any clerk of petty sessions and any other State officer shall act as such agent within his district, and with, under, and subject to such powers, conditions, and limitations as 25 are contained in such request.
- (2) Every employee or agent whose duties involve the receipt or custody of moneys or securities shall give such security for the due and faithful performance of his duties as to the Commissioner seems proper, and shall be deemed to be an accounting officer within the meaning of 30 the Audit Act, 1902.

Judicial notice.

4. The signatures of the Commissioner and of his secretary, if any, shall be judicially noticed.

Delegation by Commissioner 5. The Commissioner may from time to time, by writing under his hand, delegate to the secretary, or any officer appointed to assist him, 35 any of the powers, functions, or duties conferred or imposed on the Commissioner by this Act, and such person shall thereupon for the purpose for which he has been deputed have all the powers and may exercise all the functions of the Commissioner.

Branches and agencies.

6. The Commissioner may from time to time, for the purposes of this 40 Act, establish branches of the State Trade Office or of any department thereof at any place in New South Wales, and establish agencies of the State Trade Office at any place within or outside New South Wales, and may close any branch or agency.

Particular powers of Commissioner. 7. (1) All real and personal property of any kind (including all 45 money and securities for money) already vested in His Majesty, or that may hereafter be purchased, acquired, or held in any manner for the purposes of the State Trade Office or any State enterprise shall be held by the Commissioner under this Act, and shall be and be deemed to be vested in the Commissioner on behalf of His Majesty 50 according to the nature of the estate and interest therein respectively.

(2) The Commissioner, on behalf of His Majesty, shall, with respect to such real and personal property, and any estate or interest therein, have the power-

(i) to sell, lease, exchange, or make partition;

(ii) to accept or make surrender of leases;

10

(iii) to assign, reconvey, or discharge mortgages, securities, or other obligations, either wholly or in part;

(iv) to enter into, modify, or alter any contract or agreement with any person for all or any of the purposes of this Act;

(v) generally to exercise all other rights, powers, functions, and authorities thereover.

(3) Any property so held may from time to time be sold or disposed of upon such terms and conditions in all respects as the 15 Commissioner thinks proper.

(4) All rights, powers, functions, and authorities given to or vested in His Majesty by this Act, or under any instrument taken or purported to be taken under the authority thereof, in respect of such real and personal property, shall and may be lawfully exercised by 20 the Commissioner on behalf of His Majesty as fully and effectually as the same might or could be exercised by His Majesty; and every instrument executed by the Commissioner, and every act or thing done by the Governor under or for the purposes of this Act, shall have the same force and effect as if the same instrument were executed by, 25 or such act or thing were done by, His Majesty.

(5) Where land, whether with or without any improvements, is resumed or otherwise acquired by the Commissioner, such power shall be exercised under the Public Works Act, 1912: Provided that, in estimating the compensation to be paid on such resumption or other 30 acquirement by the Minister, no allowance shall be made for any increase in value by reason of any matter arising out of the exercise of powers under this Act.

(6) The Commissioner may erect buildings and repair, equip, furnish, and maintain the same; and let offices or other accommodation

35 in any building or premises for such rent as he thinks proper.

(7) The Commissioner may arrange with any State officer or department carrying on insurance business for the making and carrying into effect of insurance contracts in relation to the business, property, or employees of the Commissioner.

(8) The Commissioner may arrange with any Government department to supply such department with the products of a State enterprise at prices to be agreed upon, such prices not to exceed current market rates of the commodity.

(9) For the purpose of carrying on business, the Commissioner shall 45 have and may exercise all such powers, authorities, and discretions, and may do all such acts and things as a private person carrying on business in New South Wales has or may exercise or do.

(10) The Minister shall at all times have full access to all books, accounts, and papers of the State Trade Office; it shall be the duty of 50 the Commissioner to furnish him with all such returns and information as he from time to time requires.

Contracts, &c.

- 8. (1) The Commissioner may enter into contracts either at the State Trade Office or at branch offices or agencies, and either by himself or through the medium of such officers or agents as he from time to time appoints for that purpose.
- (2) Subject to this Act, the Commissioner shall have power from time to time to enter into, perform, and enforce any contracts which may be lawfully entered into by or with any person in or in relation to any business of the kind carried on by the Commissioner; and generally to do whatever he deems necessary in connection with or incident to such business.
- (3) Any contract which if made between private persons, or any power which if exercised by private persons—

firstly, must be by deed or in writing under seal;

secondly, must be in writing signed by the parties thereto or the persons executing the power;

thirdly, may be made or exercised orally without writing,

when entered into or exercised by the Commissioner, in the first case, shall be in writing under his seal, and signed by

or on behalf of the Commissioner; in the second case, shall be in writing, signed by or on behalf of 20 the Commissioner;

in the third case, may be made or exercised orally, without writing, by or on behalf of the Commissioner.

Powers of inquiry.

- 9. The Minister or Commissioner is hereby empowered to cause investigations to be made and from time to time to report and make 25 recommendations to the Governor upon all or any of the following
 - (i) Any question relating to the trade, commerce, or business of New South Wales;
 - (ii) markets for goods produced or manufactured in New South 30 Wales, and trade with other countries, and the mode of marketing;
 - (iii) generally as to how the trade, industries, and commerce of New South Wales can be best encouraged, developed, and protected.

All moneys to be property of Crown. 10. All moneys in any fund of the State Trade Office, or payable into that office by any person, and also all debts and other moneys for the time being owing to the Minister by any person, on any account whatsoever, are hereby declared to be the property of the Crown and recoverable with interest accordingly by the Commissioner as from 40 debtors to the Crown.

Payments out of such funds.

11. (1) There shall be paid out of each such fund of the State Trade Office any expenditure of or in relation to the State enterprise to which it relates, including charges for management, maintenance, working expenses, and interest on capital, and reserve fund, or sinking fund if 45 any.

Certain payments appropriated.

- (2) All payments—
- (a) for the purchase of land or buildings, or any expenditure thereon;

(b)

(b) for the purchase of stock, goods, stock in trade, furniture, fixtures, fittings, machinery, implements, or plant deemed necessary by the Commissioner for the conduct of his business, or any expenditure thereon;

(c) for expenses deemed necessary by the Commissioner for the administration of this Act and the management of State

enterprises and the State Trade Office;

shall be payable out of the proper funds, respectively, of the State Trade Office under the authority of this Act without any further or

10 other appropriation by Parliament.

5

12. (1) The receipt given by any person to the Commissioner for Discharge of any moneys paid under this Act shall be an absolute discharge to the Commissioner. Commissioner; but nothing herein shall prejudice or affect the right of any person claiming to be entitled to receive any such money to 15 recover the same from the person to whom the Commissioner has paid the same.

(2) In the event of any doubt or dispute as to the person legally Disputes by entitled to receive any moneys payable under this Act, the Commissioner claimants. may pay the same into the Supreme Court in its equitable jurisdiction 20 to abide the orders of that Court.

13. (1) With respect to any State enterprise established after the Capital cost. passing of this Act, the capital cost thereof shall be determined and declared by a committee consisting of the Auditor-General, the Under Secretary to the Treasury, and some person nominated in that behalf 25 by the Minister as soon as possible after the first capital expenditure

thereon is complete. (2) Accretions to capital cost or extraordinary losses of capital in connection with any State enterprise, whether established before or after the passing of this Act, shall be determined and declared by the

30 aforesaid committee as and when such accretions or losses shall occur.

(3) Notice of every such determination and declaration shall be

given in writing to the Commissioner, and shall be acted on.

(4) The Commissioner shall determine the amount of ordinary depreciation of the assets of each State enterprise, and such determina-35 tion shall be acted on.

14. The Commissioner, with the approval of the Minister signified Reserve funds. by writing under his hand, may, out of the net profits of any State enterprise earned during any year, set apart or invest or otherwise deal with such sum as he thinks proper towards a reserve fund for meeting 40 losses and depreciation, and for extensions of business, and for such other purposes as he deems necessary.

15. The Commissioner, with the approval of the Minister signified Investments. by writing under his hand, may invest any portion of the reserve funds or sinking funds, if any, of the State Trade Office in any of the 45 investments in which, under the Public Trustee Act, 1913, or any Act amending the same, the Public Trustee is authorised to invest trust

16. (1) The Commissioner shall cause proper books of account to be Annual balance kept in relation to each State enterprise, and shall, in each year, 50 prepare and transmit to the Minister for transmission to the Governor balance-sheets and statements of accounts, setting forth a true statement

statement of the financial position and the transactions of the State Trade Office in its several enterprises for the preceding financial year audited by the Auditor-General; and a copy of such balance-sheets and statements shall be laid before each House of Parliament as soon as practicable.

The Auditor-General shall have, in respect of such accounts, balancesheets and statements, all the powers conferred upon him by any Act

relating to the auditing of the public accounts.

(2) Each such balance-sheet and statement shall—

(a) show a profit and loss account;(b) show assets and liabilities; and

(c) be in the form prescribed by the Auditor-General.

- 17. (1) As soon as conveniently may be after the thirtieth day of June in each year, the Commissioner shall report to the Governor what, if any, in his opinion, are the net surplus profits of the State 15 Trade Office in its several enterprises after transferring such sums to the reserve funds as the Commissioner, with the written approval of the Minister, thinks proper.
- (2) The aforesaid report of the Commissioner shall be presented to Parliament
- to Parliament

 (3) Such profits of such enterprises respectively shall be dealt with as follows:—
 - (a) Until the total indebtedness on capital account of the enterprise concerned has been discharged, the net surplus profits of such enterprise shall be applied in and towards the discharge 25 of such indebtedness.
 - (b) Thereafter such net surplus profits shall be allocated in such manner as the Commissioner, with the consent of the Minister in writing, shall direct.
- 18. (1) If any employee is dismissed or is suspended, or resigns, or 30 dies, absconds, or absents himself, and if he or his wife, widow, or any of his family or representatives refuses or neglects, after seven days' notice in writing, to deliver to the Commissioner or his agent any property as herein defined in the possession or custody of such employee at the occurrence of any such event as aforesaid, then any justice of 35 the peace, upon application by the Commissioner or his agent, may order any member of the police force with proper assistance to enter and take possession of such property, and deliver the same to the Commissioner or his agent, and, if necessary, to remove any person.

(2) Every employee shall from time to time, when required by 40 the Commissioner, make and deliver to him or to his agent a true account in writing under his hand of all moneys received by him on behalf of the Commissioner.

Such account shall state how and to whom and for what purpose such moneys have been disposed of.

Together with such account, he shall deliver the vouchers and receipts for such payments.

He shall pay to the Commissioner or to his agent all moneys which appear to be owing from him upon the balance of such account.

If he fails to render such account, or to deliver all such vouchers 50 and receipts in his possession or power, or to pay the balance thereof

when required, or if for three days after being required he fails to deliver to the Commissioner or his agent all property in his possession or power, then, upon a complaint made as for a breach of duty, a court of petty sessions may hear and determine the matter in a summary 5 way, and may adjust and declare the balance owing by such employee, and make such other orders as appear to the court to be just.

If it appears, either upon his confession or upon evidence or upon inspection of the account, that any moneys which should be paid over to the Commissioner are in his hands or owing by him, such court may

10 order him to pay the same.

If he refuses to make such account in writing, or to produce and deliver to such court the vouchers and receipts relating thereto, or to deliver up any property, the court may commit him to prison, there to remain until he has complied with such order.

(3) If any employee or agent having in his possession or power Insolvency, so. of employee. any property as herein defined-

(a) becomes insolvent; or

(b) makes an assignment for the benefit of his creditors; or

(c) has any execution, attachment, or other process issued against

his land, goods, chattels, or effects, 20 the Commissioner may apply to such employee or agent, or his assignee or trustee, or to the sheriff or other person executing such process, or to his executors or administrators, or to any other person having legal right, as the case may be, and may demand that all such property be 25 paid over or delivered up to the Commissioner or such person as he may

The party so applied to and having the same shall on such demand deliver over to the Commissioner, or to such person as aforesaid, all such property, and shall pay out of the estate, assets, 30 or effects of such employee or agent all moneys due by him to the Commissioner before any other of the debts of the said employee or agent are paid or satisfied, and before the money directed to be levied by such process as aforesaid is paid over to the party issuing the same. All assets, land, goods, chattels, estate, and effects of such employee 35 or agent shall be bound to the payment and discharge thereof accordingly.

(4) If the Commissioner or his agent makes oath that he has when warrant good reason to believe, upon grounds to be stated in his deposition, may issue and does believe, that it is the intention of any employee or agent to abscond or that he has absconded, any justice of the peace may, if he 40 thinks fit, issue a warrant in the first instance for the bringing of such employee or agent before such justice or court as aforesaid.

(5) For the purposes of this section, the term "property" Meaning of includes any building or any part thereof or any appurtenance thereof, "property." or any books, papers, securities, documents, or property whatsoever 45 relating to the execution of this Act or the business of the Commissioner

or belonging to the Commissioner.

(6) No such proceeding against or dealing with any such employee Sureties not to or agent shall deprive the Commissioner of any remedy which he might be discharged. otherwise have against such employee or agent or any surety.

19. Any notice under this Act may be served personally or by post, service of addressed to the last known place of residence or business of the person notices to be served.

Protection of Minister and employees from personal liability. 20. (1) No matter or thing done and no agreement entered into by the Commissioner or any employee or other person on his behalf or under his direction shall, if the matter or thing was done or the agreement was entered into bona fide for the purposes of this Act, subject the Commissioner or any such person to any personal liability in respect thereof.

(2) An action shall not be brought against the Commissioner or any employee or other person for anything done or intended or omitted to be done under this Act until the expiration of one month after notice in writing has been served on the Commissioner or person to be sued, 10 clearly stating the cause of action and the name and place of abode of the intended plaintiff and of his solicitor or agent.

Notice of action.

On the trial of any such action the plaintiff shall not be permitted to go into evidence of any cause of action which is not stated in the notice so served.

Unless such notice is proved, the Court shall find for the defendant. Every such action shall be commenced within twelve months next after the accruing of the cause of action, and not afterwards.

Any person to whom any such notice of action is given may tender amends to the plaintiff, his solicitor, or agent, at any time within one 20 month after service of the notice, and in case the same is not accepted may plead such tender.

Obstruction.

21. Any person who in any way resists, interferes with, hinders, or obstructs any officer or person in the exercise or discharge of any power or duty under this Act is guilty of an offence, and is liable to a penalty 25 not exceeding one hundred pounds.

Recovery of penalties.

22. (1) All penalties imposed by this Act may be recovered at the option of the Minister, either in a summary way under the Justices Act, 1902, or by action in the Supreme Court before a judge thereof sitting without a jury:

Provided that no proceeding for the recovery of a penalty shall be instituted by any person whomsoever without the written direction of the Minister.

Any such proceeding may be instituted within six months after the fact of the commission of the offence against or failure of compliance 35 with this Act came to the knowledge of the Minister.

(2) All penalties recovered under this Act shall be paid to the Minister for the purposes of the State Trade Office.
