## UNIVERSITY OF NEW SOUTH WALES BILL, 1958.

### EXPLANATORY NOTE.

THE objects of this Bill are—

- (a) to alter the name of the New South Wales University of Technology to the University of New South Wales;
- (b) to extend the objects of the University to include the provision of instruction and the carrying out of research in the disciplines of humane studies and medicine and in such other disciplines as the Council of the University determines;
- (c) to provide that the statement of accounts referred to in section forty-two of the Act and the report of proceedings referred to in section forty-seven of the Act are to be prepared and submitted by the Council to the Minister as soon as practicable after 31st December, in each year.

# A BILL

To alter the name of the University constituted under the Technical Education and New South Wales University of Technology Act, 1949; to extend the objects of that University; for these and other purposes to amend that Act and certain other Acts in certain respects; and for purposes connected therewith.

B<sup>E</sup> it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as 5 follows:—

- (2) The alteration of the name of the body 20 corporate constituted under this Part effected by the amendments made to this Act by the University of New South Wales Act, 1958, does not prejudice or affect in any way the continuity of that body corporate, and that body corporate continues not-25 withstanding those amendments.
  - (3) The alteration of the name of the body corporate constituted under this Part does not affect any property, powers, rights, authorities, duties, functions, liabilities or obligations of that body corporate or of any other person, or render defective any legal or other proceedings instituted or to be instituted by or against that body corporate.
