Commencement

1. This Regulation commences on 1 September 1991.

Amendments

2. The Management of Waters and Waterside Lands Regulations—N.S.W. are amended by omitting from the Regulation specified in Column 1 of the Schedule to this clause the matter specified opposite that Regulation in Column 2 of that Schedule and by inserting instead the matter specified opposite that Regulation in Column 3 of that Schedule.

EXPLANATORY NOTE

The object of this Regulation is to amend the Management of Waters and Waterside Lands Regulations—N.S.W. so as:

- (a) to increase the fees payable in relation to occupation licences (licence fee, inspection fee, relocation fee, transfer fee, substitute vessel fee); and
- (b) to increase the fee payable for the attendance of officers of the Maritime Services Board, outside normal business hours, in relation to applications for certain licences.
