

Floodplain Management Plan (Flood Enhancement Works) Amendment Order 2024

under the

Water Management Act 2000

I, Rose Jackson MLC, Minister for Water, in pursuance of section 45(1) of the *Water Management Act 2000*, being satisfied it is in the public interest to do so, and in such circumstances, in relation to such matters and to such extent as provided for under the floodplain management plan, make the following Order to amend—

- (a) the Floodplain Management Plan for the Barwon-Darling Valley Floodplain 2017,
- (b) the Floodplain Management Plan for the Border Rivers Valley Floodplain 2020,
- (c) the Floodplain Management Plan for the Gwydir Valley Floodplain 2016,
- (d) the Floodplain Management Plan for the Lower Namoi Valley Floodplain 2020,
- (e) the Floodplain Management Plan for the Macquarie Valley Floodplain 2021, and
- (f) the Floodplain Management Plan for the Upper Namoi Valley Floodplain 2019.

Explanatory note

This Order is made under section 45(1) of the *Water Management Act 2000*. The object of this Order is to amend the floodplain management plans for the Barwon-Darling, Border Rivers, Gwydir, Macquarie and Namoi (Upper and Lower) valleys in northern NSW. The concurrence of the Minister for the Environment was obtained prior to the making of this Order as required under section 45(3) of the *Water Management Act 2000*.

1 Name of Order

This Order is the Floodplain Management Plan (Flood Enhancement Works) Amendment Order 2024.

2 Commencement

This Order commences on publication on the NSW legislation website.
